





### Appendix 6 – Test results of difference in preference

By adding all location types except the inner-city together for both low and high stress groups, a chi-square test is possible. The question asked is as follows;

Is there indeed a difference between the location choices made in case of low location stress and the choices made in case of high location stress.

The hypothesis would be as follows;

There is no difference in preference for the location-type, regarding the level of location stress.

Testing the hypothesis by means of a 2 x 2 Chi-square table gives the following result.



The results show that there is no significant difference between the choices of firms with and without location stress, however, the lower significance is attributable to the low number of observations in the category of high location stress.
